

SWORN STATEMENT COMMITMENT

Telecom Argentina S.A. conducts its activities in accordance with the values and principles contained in the Code of Ethics and Conduct, aligned with the commitment assumed with the Global Compact and the Sustainable Development Goals of the United Nations. This is implemented with the conviction that ethics, positive impact on the community and care for the environment are essential and fundamental conditions in conducting business.

Therefore, it requires from those commercially related, identical commitment to those values and principles, to the decision according to which ethics and transparency will be indispensable conditions, to the promotion of fighting against fraud and corruption and encourages the implementation of best practices that contribute to the development of the entire society and the environment. This includes:

- I. Promoting ethical business management, through:
 - A. Compliance with high standards in terms of ethics, transparency and legality;
 - B. Implementation of measures that promote prevention against corruption and fraud;
 - C. Transparent relationship with different groups of interests.
- II. Ensure social working conditions, guaranteeing:
 - A. prohibition of direct or indirect use of child labor and forced, precarious and/or unregistered labor and respect for freedom of association;
 - B. respect for human rights within its sphere of influence;
 - C. an inclusive, equitable and discrimination-free work environment.
- III. Comply with environmental regulations and mitigate the effects of climate change, emphasizing:
 - A. compliance with the RoHS directive (Restriction of Hazardous Substances) that restricts the use of six hazardous materials in the manufacture of electrical and electronic equipment (lead, mercury, cadmium, hexavalent chromium, PBB and PBDE);
 - B. non-use of blood or conflict minerals (tantalum, tin, tungsten and gold);
 - C. disclosure of the carbon footprint, recording and reporting the emission of greenhouse gases throughout the life cycle of the good, equipment and/or material to be offered;
 - D. incorporation of the labeling with energy efficiency index, when appropriate.

E) I understand and accept that breaching any of the obligations assumed herein shall be considered a serious/ essential breach and shall entitle Telecom Argentina S.A. to: i) not hire the Company I represent and / or; ii) to fully resolve any existing contract with the Company that I represent, with the sole obligation to notify the decision by written notice, Telecom Argentina S.A. being entitled to initiate actions for breach of contract and for the greater damages and losses that could be caused, with due to the application of the corresponding penalties and the execution of the guarantees (if any) and / or; iii) eliminate the Company I represent, from the "Contractors of Telecom Argentina S.A. Registry".

ANNEX: DEFINITIONS

Public Official / Subject	Any officer, employee or person acting for or on behalf of the government, or any department, agency or governmental entity thereof; a company that is owned or controlled by the State (wholly or partially) or a public/private company; or any person who holds a public office at any level and with any scope (local, provincial or national).
	Any person who holds a government office or is a public servant, elected or designated, who works at any level, agency, department or entity of the Executive, Legislative and Judicial Powers of the Nation, the Provinces, the Buenos Aires City or the Municipalities (for instance, the President of the Nation; Ministers; Governors; Mayors; members of National Congress, Legislatures and Councils; Judges, Attorneys and any other member of the Judiciary, regardless of rank, venue or jurisdiction).
	Any political party, officer, employee or person acting for or on behalf of a political party or candidate for public office (for instance, candidates to elective offices, members of any political party and officers with administrative functions hired by political parties).
	Any officer, agent or person acting for or on behalf of a Foreign State and/or a public international organization (such as the United Nations, the Organization of American States, the European Commission, the European Court of Justice, the World Bank or the International Monetary Fund) or any of its entities, branches or agencies, or of a company in which the abovementioned entities have a controlling interest or shareholding.
	All personnel hired by the agencies, entities or companies mentioned in the foregoing paragraphs, and /or advisors to any of the abovementioned officials or employees.

Compliance Program	An integrated system of organizational and procedural controls established to prevent the perpetration of illegal acts and the violation of laws, rules and regulations.
Conflict of Interests	Situation in which the private interests of a person are in conflict or otherwise interfere with the interests of Telecom Argentina S.A. (e.g., the subject has an economic interest, whether directly or through a family member, in a company that competes with the Telecom Argentina S.A.).
Anticorruption	A term that encompasses a set of behaviors, regulations and activities designed to prevent, avoid and, if applicable, report, acts of corruption and abuse of power for own benefit.
